# Approach of European Management

- In Q3 2023, more than 9.5 million people held a managerial position in the EU:
- 6.2 million men and 3.3 million women.
- Although women represent almost half of all employed persons in the EU (46%),
- they are under-represented amongst managers (34%).

#### Leadership Culture in Europe

- In the end, all leaders must gain the respect and credibility from their followers, but there are key differences as to how they do it.
- Whereas American leaders tend to resort to personal values, a sense of direction and success;
- European leaders prefer to rely on problemsolving, direct management and rational logic.

## **European Style of Management**

- European countries take a more a humanistic approach.
- A humanistic approach focuses on the needs of employees and has a concentration on the relationship between managers and employees.
- In parts of Europe, they focus on making sure managers have a fair balance between work and their private lives.

#### Management Structure of the European Union

- There are three political institutions which hold the executive and legislative power of the Union.
- The Council of the European Union represents governments,
- the Parliament represents citizens and
- the Commission represents the European interest.
